### UPDATE ON FALSE RIVER ECOSYSTEM RESTORATION PROJECT – PHASE II:

Mr. Gerald Babin of PEC gave an update on the dredging project. There is approximately 60 days left on the project. End date is projected for approximately August 25, 2019. Issues with the bag ruptures appear to have been resolved.

There was discussion regarding the upcoming drawdown and if it would affect the dredging project. Mr. Babin indicated he would speak with the contactor before any decisions needed to be made.

#### **NEW BUSINESS:**

There was a discussion on the new priorities of the False River Watershed Council and future goals of the project. Mr. Thibaut spoke about funding from legislature in Priority 1. He spoke about responsibility to maintain and repair the M1 canal bulkhead along with Lighthouse

Canal and gates. There was also funding of approximately \$3,000,000 for future restoration projects. Automated gates for the Lighthouse Canal will be about \$100,000.

There was discussion regarding Bayou Sere and the operation schedule of the Lighthouse Canal.
