SCOPE OF SERVICES FOR THE PROJECT ENGINEER

Mr. Gerald Babin, President of Professional Engineering Consultants, discussed funding from Facility Planning and Capital Outlay. He informed the council he has been gathering data for the False River project. He presented maps of south flats for Phase 1. He discussed dredging costs for terrace creation in the amount of \$2.4 million. The council discussed engineering costs. They also discussed the permitting process.

The council discussed hydraulic dredging. They also discussed time frame on drawdown.

Mr. Thibaut discussed Priority 5 being moved to Priority 1. The council discussed funding from the Pointe Coupee Police Jury and NRG. Mr. Kevin Gravois, Vice President of Professional Engineering Consultants, suggested Geotech doing layout on the south flats. The council discussed the depths of the islands to be created and how spawning is affected, as well as costs.

Mr. Van Biersel discussed scope of services with the council. After discussion, the following motion was offered.

RESOLVED, That the scope of services for the improvement of False River go before the Pointe Coupee Police Jury for approval.
